You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a Fund with the HSBC Unifolio, a Guernsey unit trust scheme, established as an umbrella fund. The HSBC Unifolio, the Manager and the Trustee are subject to the GFSC Class 'B' Rules.

Objectives

The Fund aims to provide a total return from selective investments in a number of hedge funds which have been subject to due diligence and manager selection by HSBC. At least two thirds of the Fund will be invested in commodity trading adviser and managed futures strategies. Hedge funds that employ these strategies usually employ a systematic or trend following approach that is focused on pricing action, pattern recognition and momentum factors.

Investment Policy:

- ▶ The Fund aims to provide exposure to a globally diversified portfolio of hedge funds, with a focus on commodity trading adviser and managed futures strategies.
- ▶ Hedge funds within the Fund ("Portfolio Funds") will have considerable flexibility in terms of both the instruments and strategies that they employ.
- ▶ The Portfolio Funds will generally make use of a wide range of investment instruments and techniques including derivative products and leverage. They may take both long and short positions either directly, using leverage or via derivatives.
- ▶ Portfolio Funds are generally based offshore and are often subject to less regulatory oversight.
- ▶ Portfolio Funds will have different dealing frequencies. At each Valuation Point a minimum of 40% of the Net Asset Value ("NAV") of the Fund will be held in Portfolio Funds with

a monthly dealing frequency or less. A further 40% of the NAV of the Fund will be held in Portfolio Funds with a quarterly dealing frequency or less. 20% of the NAV of the Fund may be held in Portfolio Funds with a dealing frequency in excess of quarterly. No single fund may make up more than 20% of the NAV.

- ▶ The Fund may borrow up to a total of 25% of the NAV of the Fund for a range of purposes including up to 10% for investment purposes.
- ▶ The Fund may use derivative transactions for the purpose of hedging. Assets and liabilities expressed in currencies other than the reference currency of the Fund may be hedged back to the relevant reference currency.
- ▶ Each Portfolio Fund has its own cost structure, meaning that investors will be subject to the costs incurred by Portfolio Funds as well the costs incurred by the Fund directly.

Intended retail investor

The Fund aims to meet the needs of investors who are looking for growth with an investment time horizon of at least five years. The Fund is designed for use as part of a diversified portfolio. Investors buying the Fund need to have a high level of knowledge and experience about investing in Alternative Investment Funds ("AIFs"). Investors should be aware that the Fund is not guaranteed and they could see significant changes to the value of their investment.

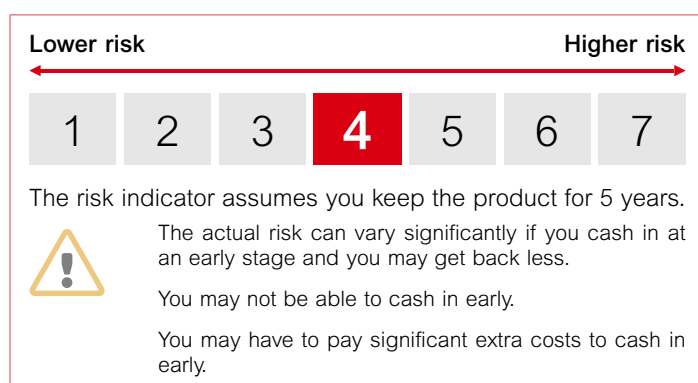
Terms of PRIIPS

Subscriptions are accepted monthly, with 5 business days' notice. Redemptions are accepted monthly with 1 month plus 5 business days' notice.

The Manager has the right to suspend or limit monthly dealing. The Fund is valued monthly.

Risk Indicator

What are the costs?

Costs over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

¹ **Portfolio transaction costs** are an estimate of the embedded costs of buying or selling of financial instruments by underlying hedge funds in the pursuit of their investment strategies (typically, implicit trading spread-related costs).

² **Other ongoing costs** and **Performance fees** are each comprised of two primary components:

- The estimated ongoing costs (including management fees) and performance fees paid to the underlying hedge fund managers. These generally comprise the majority of both costs.
- The relevant charges for the investment services provided by HSBC and its affiliates for investment management services, safeguarding and administration.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years
