# HSBC MSCI WORLD SMALL CAP SCREENED UCITS ETF

## Investment objective

The Fund aims to track as closely as possible the returns of the MSCI World Small Cap Selection Screens Index (the Index), while integrating environmental, social and governance (ESG) metrics. The Fund will invest in or gain exposure to shares of companies which make up the Index. The Fund qualifies under Article 8 of SFDR.

## Investment strategy

The Index is a subset of the MSCI World Index (Parent Index), and is made up of small cap companies based in certain developed market countries, as defined by the Index Provider. The Index is constructed by screening all securities of companies and excluding securities with exposure to: controversial and nuclear weapons, adult entertainment, alcohol, gambling, nuclear power, thermal coal power, fossil fuel and tobacco.

The Fund is passively managed and utilises an investment technique called optimization. The Fund aims to invest in the shares of the companies in generally the same proportion as in the Index. There may be circumstances when it is not possible for the Fund to invest in all constituents of the Index.

The Fund may invest up to 10% of its assets in other funds, up to 35% of its assets in securities from a single issuer during exceptional market conditions and up to 10% in total return swaps and contracts for difference.






