Objectives and Investment Policy

Investment Objective:

The Fund aims to provide regular income and capital growth by tracking as closely as possible the performance of the Bloomberg China Treasury + Policy Bank Index (total return) (the Index).

Investment Policy:

The Index is comprised of Renminbi (CNY) denominated treasury bonds that are listed on China Interbank Bond Market. The currency of the Index is US dollars (USD) and returns are unhedged.

The Index includes fixed-rate government and policy bank bonds with a minimum outstanding amount of at least CNY 5 billion, and a maturity of at least one year.


The Fund is passively managed and invests in, or gain exposure to CNY bonds all of which are Index constituents. If the overall portfolio matches the characteristics of the Index, the Fund can also invest outside of the Index; into securities which are expected to provide similar performance and risk characteristics to certain Index constituents, or that were or will be Index constituents. The Fund may invest in cash and money market instruments, may

invest up to 10% of its assets in funds for efficient portfolio management purposes, may invest up to 100% of its assets in non-investment grade bonds.

The Fund may invest more than 10% and up to 100% of its assets in government bonds issued by a single government issuer (the People's Republic of China) which may be non-investment Grade; and may invest up to 20% in securities issued by the same non-government issuer. In exceptional market conditions this limit may be increased to 35%. The Fund may also invest in derivatives for hedging and efficient portfolio management purposes (such as to manage risk and costs, or to generate additional capital or income).

- The Fund may enter into securities lending transactions for up to 30% of its assets. However, this is not expected to exceed 25%.
- The reference currency of your shares is GBP. Your shares seek to hedge the currencies of denomination of the underlying portfolio assets to GBP.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 3 years.


