Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth by tracking as closely as possible the performance of the MSCI Japan Net Total Return Index (the Index).

Investment Policy:

The Index is comprised of large and medium sized companies (as defined by the market value of their shares, also known as market capitalisation) in Japan, as defined by the Index provider. The Fund is passively managed and aims to invest in the shares of the companies in generally the same proportion as in the Index. There may be circumstances when it is not possible or practical for the Fund to invest in all constituents of the Index. If the Fund cannot invest directly in the companies that constitute the Index, it can gain exposure by using other investments such as depositary receipts, derivatives and funds.

The Fund may also invest in money market instruments and may invest up to 10% of its assets in other funds, including HSBC funds.

Why is this Fund in this specific category?

This Fund is classified in category 6 because its price or simulated data has shown high fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

 Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations. The Fund may invest up to 10% of its assets in total return swaps. However, this exposure is not expected to exceed 5%. The Fund may invest up to 20% in securities from a single issuer, however in exceptional market conditions the Fund can invest up to 35% for one single issuer.

The Fund may also invest in derivatives for hedging and efficient portfolio management purposes (such as to manage risk and costs, or to generate additional capital or income).

- The Fund may enter into securities lending transactions for up to 30% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is JPY. The reference currency of this share class is EUR.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- Derivatives Risk Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.
