Dear Unitholder,

This notification follows our previous unitholder notice dated 10 December 2025 in which we informed you of our proposal to change the index tracked by the HSBC UCITS Common Contractual Fund - Islamic Global Equity Index Fund (the “**Fund**”), a sub-fund of HSBC UCITS Common Contractual Fund. As explained in that notice, the board of directors of the manager, Carne Global Fund Managers (Ireland) Limited (the “**Board**”), in consultation with HSBC Global Asset Management (UK) Limited (the “**Investment Manager**”), completed a review of the index tracked by the Fund and confirmed a change of index based on client feedback.

This notification is to inform you that, following completion of the review, the Fund intends to change the index tracked by the Fund, as further described below. The proposal has received no objection from the Central Bank of Ireland (the “**Central Bank**”).

Details of the Index Change

The Fund’s index will be changed as shown in the table below.
