Objectives and Investment Policy

Investment Objective:

The Fund aims to track as closely as possible the returns of the MSCI World Value Select Screens Advanced Index (the Index), that provides investors the opportunity to gain specific exposure to companies with lower market valuations relative to their fundamental value (the Value Factor), while integrating environmental, social and governance (ESG) metrics. The Fund will invest in or gain exposure to shares of companies which make up the Index.

Investment Policy:

The Index is a subset of the MSCI World Index (Parent Index), and is made up of large and mid-cap companies (as measured by the market value of their shares) based in developed market countries, as defined by the Index Provider. In replicating the performance of the Index, the Fund promotes certain environmental, social and/or governance (ESG) characteristics and has been categorised as an Article 8 fund for the purpose of the SFDR.

The Index applies screens to the Parent Index to exclude securities of companies with exposure to: controversial and nuclear weapons, adult entertainment, alcohol, gambling, nuclear power, thermal coal power, fossil fuel and tobacco. The Index aims to maximise the exposure to the Value Factor using a proprietary factor model along with a 20% ESG score improvement of the Index relative to the Parent Index. The proprietary factor model after applying exclusion criteria, measures the exposure of each remaining security to the Value Factor using three value-specific variables (price-to-book value, price-to-forward earnings, and enterprise value-to-cash flow from operations) and ranks the securities providing maximum exposure to the Value Factor. The Index is rebalanced on a quarterly basis. Please refer the Fund's Supplement for more details on ESG exclusion criteria and Value Factor.

The Fund is passively managed and aims to invest in the shares of the companies in generally the same proportion as in the Index. There may be circumstances when it is

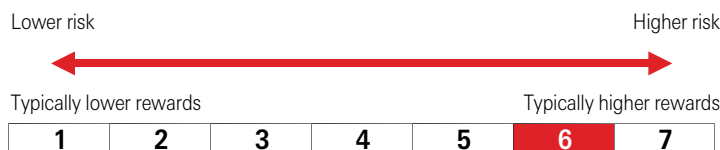
not possible for the Fund to invest in all constituents of the Index and may gain exposure by using other investments such as depositary receipts, funds, or derivatives. The Fund may invest up to 10% of its assets in other funds, including HSBC funds. The Fund may invest up to 35% of its assets in securities from a single issuer during exceptional market conditions.

The Fund may invest up to 10% in total return swaps and contracts for difference. However, this is not expected to exceed 5%.

The Fund may also invest in derivatives for efficient portfolio management purposes (such as to manage risk and costs, or to generate additional capital or income) and for investment purposes.

- ◆ The Fund may enter into securities lending transactions for up to 30% of its assets. However, this is not expected to exceed 25%.
- ◆ Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency CHF and the base currency of the Fund USD.
- ◆ Income is reinvested.
- ◆ Authorised Participants only may deal in the Fund's shares directly with the UCITS.
- ◆ The Fund's shares are listed on one or more stock exchange(s).
- ◆ You may sell your investment on most working days.
- ◆ Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- ◆ This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

Why is this Fund in this specific category?

Material risks not fully captured by the Risk and Reward Indicator:

- ◆ **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.

- ◆ **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- ◆ **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- ◆ **Index Tracking Risk** To the extent that the Fund seeks to replicate index performance by holding individual securities, there is no guarantee that its composition or performance will exactly match that of the target index at any given time ("tracking error").
- ◆ **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- ◆ **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- ◆ **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.
