Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long-term capital growth.

Investment Policy:

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies incorporated in the US or those that earn the majority of their revenue from the US

The Investment Manager identifies stocks which may or may not comprise the S&P 500 Index (USD Net Total Return) and uses a proprietary quantitative investment process to create a portfolio which focuses on risk premia offered by exposure to factors such as value, quality, momentum, low risk and size.

The investment approach is subject to ongoing research regarding the above factors. A portfolio is then created which maximises the exposure to the highest ranked equity securities based on the above factors while minimising the portfolio's risk.


The Fund may hold cash and money market instruments such as bills, commercial paper, and certificates of deposits for ancillary liquidity purposes.

The Fund may invest up to 10% of its assets in other funds, including HSBC funds.

The Fund may invest up to 10% of its assets in total return swaps. However, this exposure is not expected to exceed 5%. The Fund may also invest in derivatives for efficient portfolio management purposes (such as to manage risk and costs, or to generate additional capital or income).

- The Fund may enter into securities lending transactions for up to 30% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, S&P 500 Net total Return index.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance relative to the benchmark is also monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.


