Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long-term capital growth and seeks to invest in instruments that offer thematic equity exposure.

Investment Policy:

The Fund invests in listed shares predominantly in, but not limited to, the materials sectors. The Fund will invest up to 100% of its assets in shares (and other similar securities) linked to transition resources and services that are critical to enabling a clean energy eco-system. The Fund identifies which companies are on a clear and measurable climate transition pathway as informed by the Investment Manager's proprietary climate transition assessment to determine a company's progress or commitment towards alignment with "Net Zero" pathways.

The Fund may invest in shares and other transferable securities such as convertible securities, preferred securities, participation notes, convertible preferred securities, warrants and rights or securities similar to shares which are listed or traded on recognised markets worldwide.

The Fund aims to provide long-term value by investing in a concentrated portfolio of shares (and other similar securities) of companies globally that enable the global energy transition by providing the relevant production, financing, technology and/or equipment, and other companies in the global transition resources value chain, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of the European Union's SFDR. To achieve this, the Investment Manager first identifies companies that exist within the three key segments: Materials, Enablers and Supply Chain and defines an investment universe for the Fund by identifying companies that exist within the key segments. At least 80% of underlying investment holdings will have a minimum of 20% revenues related to transition resources products and services.

The Fund will not invest in: issuers with involvement in specific excluded activities, such as the production of banned or controversial weapons and tobacco; IPOs by companies engaged in expansion of thermal coal production and non-compliance with UNGC principles; issuers with more than 10% of revenue generated from thermal coal power. Please refer to the Fund's supplement for more details on the excluded activities and specific involvement.

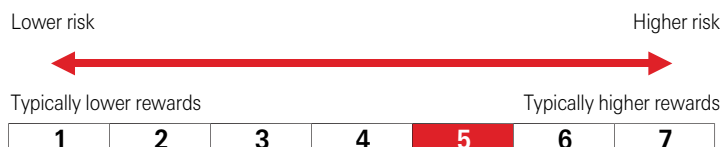
Following the application of excluded activities to the investment universe, the Investment Manager applies a sustainability framework to evaluate a company's ESG characteristics, incorporating both quantitative and qualitative analysis to each segment.

The Fund may invest up to 10% of its asset in cash and other funds for ancillary liquidity purposes. The Fund may invest up to 5% of its assets in a single fund.

The Fund may also invest in derivatives for hedging and efficient portfolio management purposes (such as to manage risk and costs, or to generate additional capital or income).

- ◆ The Fund may enter into securities lending transactions for up to 30% of its assets. However, this is not expected to exceed 25%.
- ◆ The reference currency of the Fund is USD. The reference currency of this share class is GBP.
- ◆ The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, MSCI ACWI Materials Net Total Return Index (USD).
- ◆ The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that the reference benchmark will not be used as a universe from which to select securities.
- ◆ Income is reinvested.
- ◆ You may sell your investment on most working days.
- ◆ Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- ◆ This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

Material risks not fully captured by the Risk and Reward Indicator:

- ◆ **Concentration Risk** The Fund may be concentrated in a limited number of securities, economic sectors and/or countries. As a result, it may be more volatile and have a greater risk of loss than more broadly diversified funds.

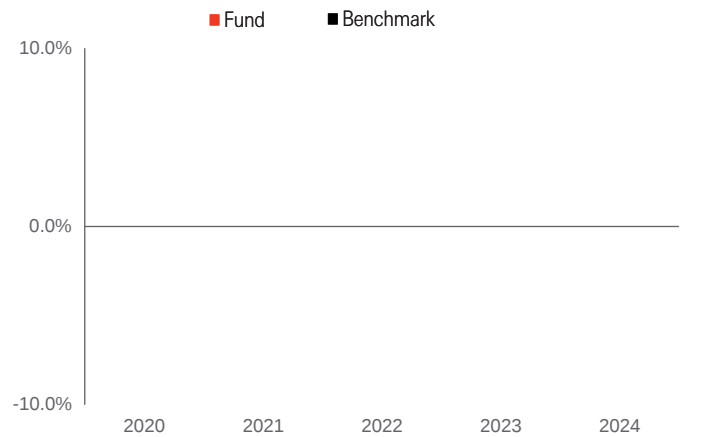
- ◆ **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- ◆ **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- ◆ **Emerging Markets Risk** Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.
- ◆ **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- ◆ **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- ◆ **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- ◆ **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

HSBC Global Funds ICAV is an open-ended umbrella type Irish collective asset-management vehicle with limited liability and segregated liability between sub-funds incorporated under the laws of Ireland. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.
