# **Objectives and Investment Policy**

# Investment Objective:

The Fund aims to provide capital growth and income by investing in a portfolio of Eurozone shares, while promoting environmental, social and governance (ESG) characteristics. The Fund aims to have a higher ESG score than its reference benchmark. The Fund aims to have a higher ESG score than its reference benchmark; calculated as a weighted average of the ESG scores of the companies of the Fund's investments versus the weighted average of the ESG scores of its reference benchmark.

# **Investment Policy:**

The Fund will normally invest at least 90% of its assets in equity securities (shares) of companies and similar securities.

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of smaller and medium sized companies, that are based in any Eurozone member country. These companies are defined as having a market value of less than EUR 10 billion as well as being constituents of the MSCI EMU SMID Index. The Fund includes the identification and analysis of a company's ESG Credentials as an integral part of the investment decision making process to help assess risks and potential returns. This analysis is applied to a minimum of 70% of the Fund's portfolio. ESG Credentials may include environmental and social factors, and corporate governance practices. Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset

Management's Responsible Investment Policies, which may change from time to time. Please refer to the prospectus for more details on ESG Credentials and excluded activities.

ESG Credentials, Excluded Activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & expertise from well-established financial data providers.

- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that the reference benchmark will not be used as a universe from which to select securities.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.


