# Investment objective

The Fund aims to provide long-term capital growth and income by investing in a portfolio of Euro denominated bonds, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of SFDR. The Fund aims to have a higher ESG score than its reference benchmark.



## Investment strategy

The Fund is actively managed. The Fund will normally invest at least 90% in Euro denominated investment grade bonds and similar securities issued by governments, government agencies, supranational bodies or companies based in any country including developed markets and emerging markets. The Fund includes the identification and analysis of an issuer's environmental and social factors and corporate governance practices as an integral part of the investment decision making process. Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. The Fund may invest up to 10% in bonds issued by issuers based in emerging markets, up to 10% in asset-backed and mortgage-backed securities, up to 10% in contingent convertible securities and up to 10% in other funds. ## Main risks


- The value of investments and any income from them can go down as well as up and investors may not get back the amount originally invested


