Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of Türkiye shares.

Investment Policy:

In normal market conditions, the Fund will primarily invest in shares (or securities similar to shares) of companies of any size, that are based in, or carry out most of their business in Türkiye.

Companies considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset

Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on excluded activities.


The Fund may invest up to 10% of its assets in other funds, including HSBC funds, and may invest in bank deposits and money market instruments for treasury purposes.

The Fund may use derivatives for hedging and cash flow management. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is EUR. The reference currency of this share class is EUR.

- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is BIST 100.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The reference benchmark has a high level of concentration. This means that a small number of securities make up a significant proportion of the benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

Material risks not fully captured by the Risk and Reward Indicator:

 Concentration Risk The Fund may be concentrated in a limited number of securities, economic sectors and/or countries. As a result, it may be more volatile and have a greater risk of loss than more broadly diversified funds.

- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.
