# **Objectives and Investment Policy**

# Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of Eurozone shares, while promoting environmental, social and governance (ESG) characteristics. The Fund aims to have a higher ESG score, calculated as a weighted average of the ESG scores given to the issuers of the Fund's investments, than the weighted average of the constituents of its reference benchmark. The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at

# **Investment Policy:**

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size, that are based in, or carry out most of their business in any European Monetary Union member country. The Fund typically focuses on profitable companies with higher than average reinvestment rates in order to maintain and/or increase their current level of growth. The Fund includes the identification and analysis of a company's ESG credentials as an integral part of the investment decision making process, to help assess risks and potential returns. This analysis is applied to a minimum of 90% of the Fund's portfolio. ESG credentials may include environmental and social factors, and corporate governance practices. Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on ESG credentials and excluded activities. ESG credentials, excluded activities and the need for enhanced due diligence may be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers.

# Material risks not fully captured by the Risk and Reward Indicator:

 Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations. The Fund may invest up to 10% of its assets in Real Estate Investment Trusts (REITs), up to 10% in other funds, and may invest in bank deposits and money market instruments for treasury purposes. The Fund may also invest in derivatives and use them for hedging, efficient portfolio management purposes and cash flow management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is EUR. The reference currency of this share class is EUR.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, MSCI EMU Net.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that the reference benchmark will not be used as a universe from which to select securities.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.



#### Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between subfunds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other subfund.
