### **Objectives and Investment Policy**

#### **Investment Objective:**

The Fund aims to provide long term capital growth and income by investing in a portfolio of emerging markets bonds and other similar securities or instruments.

The Fund employs a Total Return strategy which has a flexible allocation across the emerging market debt universe. Through seeking multiple sources of return the strategy aims, over an investment cycle, to achieve risk-adjusted returns above those of the investment universe. However, your capital is still at risk and there is no guarantee of stable growth over time.

In normal market conditions, the Fund will mostly invest its assets in investment grade bonds and non-investment grade bonds issued or guaranteed by governments, government-related entities, supranational entities, and companies that are based in or carry out the larger part of their business in emerging markets. As the markets the Fund invests in are considered to be emerging (meaning their economies are still developing), you could be exposed to some additional risk.

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on excluded activities.

The Fund may invest up to 10% of its assets in Chinese onshore bonds through the China Interbank Bond Market (CIBM).

The Fund may invest up to 49% of the Fund's net assets in cash, cash instruments and/ or money market instruments which may be issued by governments in developed


The Fund may also invest up to 25% of its assets in convertible bonds (excluding contingent convertible securities), up to 10% of its assets in contingent convertible securities, up to 10% in other funds, and may invest in bank deposits and money market instruments for treasury purposes.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings The Fund is managed to provide a US Dollar return. The Fund's primary currency exposure is to the US Dollar and emerging market currencies.

The Fund may also use derivatives for hedging or efficient portfolio management purposes (such as to manage risks or costs or to generate additional capital or income). Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency EUR and the base currency of the Fund USD.
- The reference benchmark, shown in the past performance section, does not take account of currency hedging. There may be a greater difference between the past performance of the share class and the reference benchmark than for other share classes in the Fund.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is Secured Overnight Financing Rate (SOFR).
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

#### Why is this Fund in this specific category?

### Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively impact the performance of callable debt securities (securities whose issuers have the right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.


