Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of shares from Brazil, Russia, India and China (including Hong Kong SAR).

Investment Policy:


In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size, that are based in, or carry out most of their business in Brazil, Russia, India and/or China (including Hong Kong SAR).

Companies considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on excluded activities.

Investments in Chinese share markets include China A-shares and China B-shares with a maximum exposure of 50% of the Fund's assets. The Fund may invest up to 40% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect. The Fund may invest up to 30% of its assets in China A-shares indirectly through China A-shares Access Products (CAAP) and may invest up to 10% of its assets in CAAPs issued by any single issuer. The Fund may invest up to 10% of its net assets in other funds, including HSBC funds, and may invest in bank deposits and money market instruments for treasury purposes.

The Fund may also invest in derivatives. The Fund may use them for hedging and cashflow management purposes. Derivatives will not be

 Concentration Risk The Fund may be concentrated in a limited number of securities, economic sectors and/or countries. As a result, it may be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.
