# **Objectives and Investment Policy**

# Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of Renminbi (RMB) bonds and other similar securities.

## **Investment Policy:**

The Fund primary invests in bonds and other similar securities denominated in RMB either issued outside of the People's Republic of China (PRC), or issued within the PRC and traded on the China Interbank Bond Market (CIBM) or stock exchanges in the PRC. The Fund may achieve RMB exposure through investments in structured products and may invest in non-RMB denominated bonds and similar securities achieving RMB exposure through derivatives.

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to

the Prospectus for more details on excluded activities. The Fund will invest in investment grade, non-investment grade and unrated bonds and

other similar securities (including, but not limited to, bonds, certificate of deposits and money market instruments) which are either issued or guaranteed by governments, government agencies and supranational bodies or by companies.

The Fund may invest up to 100% of its assets in Chinese onshore bonds and similar securities through the China Interbank Bond Market (CIBM), with a maximum of 10% in non-investment grade rated.


The Fund may invest up to 10% of its assets in cash and cash equivalents.

The Fund may invest up to 10% of its assets in convertible bonds (excluding contingent convertible securities).

The Fund may invest up to 10% of its assets in contingent convertible securities. However, this exposure is not expected to exceed 5%.

The Fund may also invest up to 10% of its assets in other funds, including HSBC funds, and may invest in bank deposits, money market instruments or money market funds for treasury purposes.

# Why is this Fund in this specific category?

This Fund is classified in category 3 because its price or simulated data has shown low to medium fluctuations historically.

## Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively
  impact the performance of callable debt securities (securities whose issuers have the
  right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- Concentration Risk The Fund may be concentrated in a limited number of securities, economic sectors and/or countries. As a result, it may be more volatile and have a greater risk of loss than more broadly diversified funds.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings. The Fund may also invest in derivatives and use them for hedging and efficient portfolio management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is CNY.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, 50% Markit iBoxx ALBI China Onshore Total Return Index Unhedged 50% Markit iBoxx ALBI China Offshore Total Return Index Unhedged.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.



# Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.
