**Objectives and Investment Policy** 

#### **Investment Objective:**

The Fund aims to provide long term capital growth and income by investing in a portfolio of Indian bonds and other similar securities. **Investment Policy:** 

The Fund will normally invest at least 90% of its assets in: investment and noninvestment grade, as well as unrated Indian domestic bonds and similar securities denominated in Indian Rupee (INR). These will be government, supranational and/or corporate issues; investment and non-investment grade, as well as unrated bonds and similar securities issued or guaranteed by the government or government agencies of India, as well as by companies which carry out most of their business in India, that are denominated in other currencies; other instruments referencing underlying exposure to INR bonds; cash and cash instruments up to a maximum of 20% of assets.

The Fund may be subject to a limit on its investments in India. Where this is the case, the Fund may invest in non-INR denominated securities outside of India.

Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on excluded activities.

The Fund may invest up to 100% in securities issued or guaranteed by the Indian government or Indian government agencies.

The Fund may invest up to 10% of its assets in contingent convertible securities. The Fund may invest up to 10% of its assets in other funds, including other funds of HSBC, and may invest in bank deposits, money market instruments or money market funds for treasury purposes.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may also invest in derivatives and use them for hedging and efficient portfolio management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

## Why is this Fund in this specific category?

This Fund is classified in category 3 because its price or simulated data has shown low to medium fluctuations historically.

## Material risks not fully captured by the Risk and Reward Indicator:

- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Credit Řisk A bond or money market security could lose value if the issuer's financial health deteriorates.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.

- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, Crisil Composite Bond Dollar Index.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- The reference benchmark has a high level of concentration. This means that a small number of securities make up a significant proportion of the benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.


