## Objectives and Investment Policy

### Investment Objective:

The Fund aims to provide a long-term capital growth and income by investing in a portfolio allocated across the full spectrum of Euro denominated bonds and other similar securities.

### Investment Policy:

The Fund employs a Total Return strategy that aims to capture the majority of the upside in the Euro credit universe while limiting the downside risk and has a flexible allocation across the bond market. Through seeking multiple sources of return the strategy aims, over an investment cycle, to achieve risk-adjusted returns above those of the investment universe. You should be aware that your capital is at risk and there is no guarantee of stable growth over any time period.

In normal market conditions, the Fund will mostly invest its assets in investment grade and non-investment grade bonds, and other similar securities, denominated in Euro, issued or guaranteed by governments, government-related entities, supranational entities, and companies that are based in or carry out the larger part of their business in developed markets. The Fund may invest up to 49% of its assets in cash, and/or money market instruments.

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on excluded activities.

The Fund may also invest up to 10% of assets in bonds which are issued by companies, governments, or government agencies of emerging market countries, that are denominated in hard currency, Euro or hedged into Euro.

The Fund mostly invests in bonds which are denominated in Euro. Normally the Fund's exposure to other developed markets currencies will be limited to 10%.

The Fund may invest up to 10% of its assets in convertible bonds (excluding contingent convertible securities) and up to 10% in asset-backed securities (ABS) and mortgage-backed securities (MBS).

The Fund may invest up to 15% of its assets in contingent convertible securities, however this is not expected to exceed 10%.


The Fund may invest up to 10% in other funds and may also invest in bank deposits and money market instruments for treasury purposes.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may also invest in derivatives and use them for hedging, cashflow management and investment purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- ◆ The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- ◆ The reference currency of the Fund is EUR. The reference currency of this share class is EUR.
- ◆ The Fund is actively managed and is not constrained by a benchmark.
- ◆ Income is reinvested.
- ◆ You may sell your investment on most working days.
- ◆ Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- ◆ This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

### Why is this Fund in this specific category?

### Material risks not fully captured by the Risk and Reward Indicator:

- ◆ **Callable Bond Risk** Any unexpected behaviour in interest rates could negatively impact the performance of callable debt securities (securities whose issuers have the right to pay off the security's principal before the maturity date).
- ◆ **CoCo Bond Risk** Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.


- ◆ **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- ◆ **Credit Risk** A bond or money market security could lose value if the issuer's financial health deteriorates.
- ◆ **Default Risk** The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- ◆ **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- ◆ **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- ◆ **Interest Rate Risk** When interest rates rise, bond values generally fall. This risk is generally greater the longer the maturity of a bond investment and the higher its credit quality.
- ◆ **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- ◆ **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- ◆ **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.
