Investment objective

The Fund aims to provide long term capital growth and income by investing in a portfolio of emerging market local currency bonds, foreign exchange forwards and other similar securities, while promoting environmental, social and governance (ESG) characteristics. The Fund qualifies under Article 8 of SFDR.

Investment strategy

The Fund is actively managed. The Fund will invest at least 80% of its assets in investment grade and non-investment grade rated bonds, and other similar securities, issued by governments, government related entities or companies of emerging markets, as well as currency forwards and non-deliverable forwards. These are issued by issuers meeting certain minimum ESG and E, and S and G scores and the consideration of lower carbon intensity criteria. Minimum ESG and E, and S and G scores and lower carbon intensities are based on specific measures such as: electricity produced by renewable energy sources and carbon emissions as provided by the Sustainable Accounting Standards Board. The Fund will invest in sustainable bonds such as: sustainabilitylinked bonds, transition bonds, social bonds and green bonds. The average maturity of the Fund is normally between 4 and 10 years. The Fund may invest up to 20% in onshore Chinese bonds, up to 10% in convertible bonds, up to 10% in other funds, may invest in bank deposits and money market instruments. The Fund's primary currency exposure is to emerging market currencies. See the Prospectus for a full description of the investment objectives and derivative usage.

🖄 Main risks




