Investment objective

The Fund aims to provide long-term capital growth and income by investing in a portfolio of Euro denominated bonds, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of SFDR. The Fund aims to have a higher ESG score than its reference benchmark.



Investment strategy

The Fund is actively managed. The Fund will normally invest at least 90% in Euro denominated investment grade bonds and similar securities issued by governments, government agencies, supranational bodies or companies based in any country including developed markets and emerging markets. The Fund includes the identification and analysis of an issuer's environmental and social factors and corporate governance practices as an integral part of the investment decision making process. Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. The Fund may invest up to 10% in bonds issued by issuers based in emerging markets, up to 10% in asset-backed and mortgage-backed securities, up to 10% in contingent convertible securities and up to 10% in other funds. Main risks

- Investing in assets denominated in a currency other than that of the investor's own currency exposes the value of the investment to exchange rate fluctuations
- The Fund invests in bonds whose value generally falls when interest rates rise. This risk is typically greater the longer the maturity of a bond investment and the higher its credit quality. The issuers of certain bonds, could become unwilling or unable to make payments on their bonds and default. Bonds that are in default may become hard to sell or worthless.

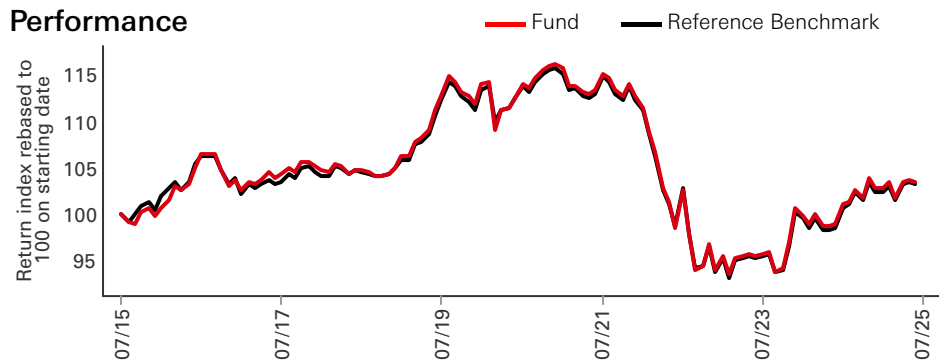

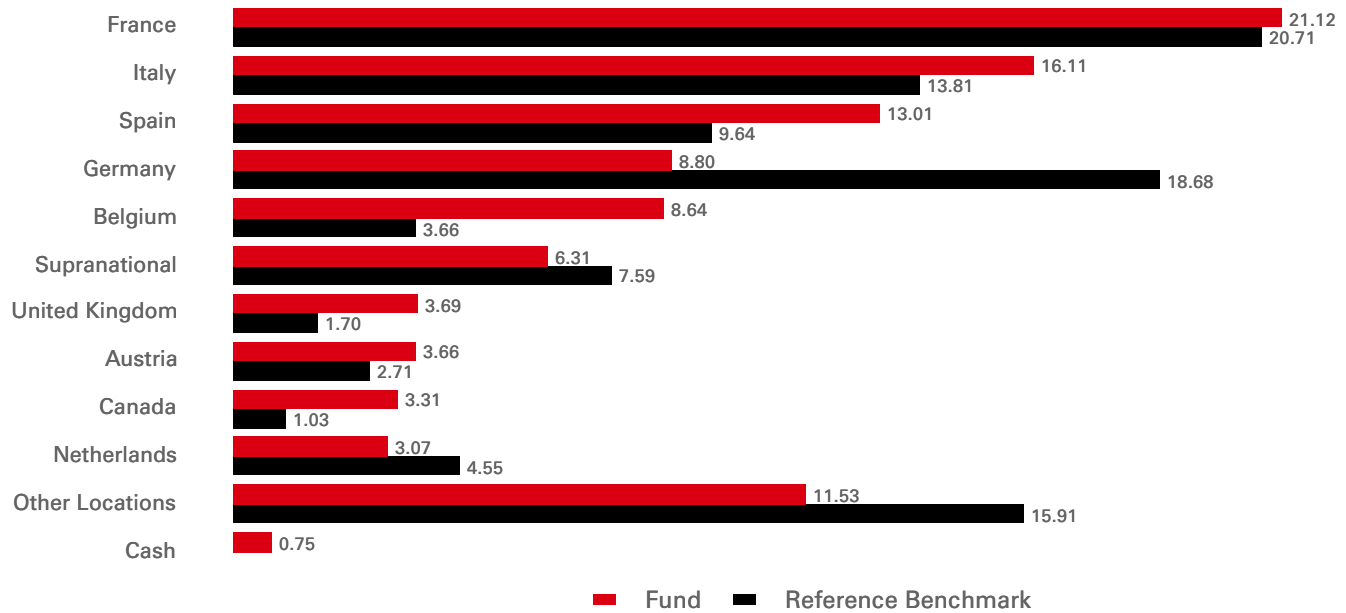
