Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of corporate bonds, while promoting environmental, social and governance (ESG) Characteristics. The Fund aims to do this with a higher ESG score, calculated as a weighted average of the ESG scores given to the issuers of the Fund's investments, than the weighted average of the constituents of its reference benchmark. The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. In normal market conditions, the Fund will invest at least 70% of its assets in a combination of investment grade bonds and other similar securities issued by companies in both developed markets and emerging markets, and in asset-backed securities (ABS) and mortgage-backed securities (MBS). With up to a maximum of 20% of its assets in ABS and MBS.

The Fund includes the identification and analysis of a company's ESG credentials as an integral part of the investment decision making process to help assess risks and potential returns. ESG Credentials may include environmental and social factors, and corporate governance practices. Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on ESG credentials and excluded activities.

ESG credentials, excluded activities and the need for enhanced due diligence may be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers. The Fund may invest up to 10% of its assets in onshore Chinese bonds through the China Interbank Bond Market (CIBM).

The Fund may invest up to 10% of its assets in convertible securities (excluding contingent convertible securities), up to 10% in non-investment grade rated bonds, may also invest in bank deposits and money market instruments for treasury purposes and up to 10% in other funds.

The Fund may invest up to 10% of its assets in contingent convertible securities. However, this is not expected to exceed 5%. The Fund mostly invests in US Dollar (USD) denominated bonds. Non-USD exposures will normally be hedged into USD; non-USD exposures will be limited to 10% of assets and may be to emerging markets currencies.

The Fund may also invest in derivatives and use them for hedging, efficient portfolio management and cash flow management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency CHF and the base currency of the Fund USD.
- The reference benchmark, shown in the past performance section, does not take account of currency hedging. There may be a greater difference between the past performance of the share class and the reference benchmark than for other share classes in the Fund.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, Bloomberg Global Aggregate Corporates AWS Hedged USD.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.



Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 30 January 2025.
