Objectives and Investment Policy

Investment Objective:

The Fund aims to provide capital growth and income by investing in a portfolio of noninvestment grade bonds (denominated in US dollars).

Investment Policy:

In normal market conditions, the Fund will invest at least 90% of its assets in noninvestment grade bonds and other high yielding bonds (including unrated bonds) issued or guaranteed by governments, government-related entities, state sponsored enterprises, local or regional governments, supranational entities, and by companies. The Fund will normally hedge non-US dollar exposures into US dollars (USD). Normally the Fund's exposure to non-USD currencies will be limited to 20% of its assets. The Fund may invest up to 30% of its assets in investment grade bonds to manage liquidity.

The Fund may also invest up to 10% in asset-backed securities (ABS).

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on excluded activities.

The Fund may invest up to 10% of its assets in onshore Chinese bonds which are issued within the People's Republic of China and traded on the China Interbank Bond Market.

The Fund may invest up to 10% of its assets in securities issued by or guaranteed by any single government issuer with a credit rating below investment grade. The Fund may invest up to 10% in convertible bonds (excluding contingent convertible

securities) and may also invest in bank deposits and money market instruments for treasury purposes.

The Fund may also invest up to 15% of its assets in contingent convertible securities. However, this exposure is not expected to exceed 10%.

The Fund may invest up to 10% of its assets in other funds, including HSBC funds. The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may also invest in derivatives. The Fund may use them for hedging, cashflow management and investment purposes. Derivatives will not be used extensively for

Why is this Fund in this specific category?

- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency CHF and the base currency of the Fund USD.
- The reference benchmark, shown in the past performance section, does not take account of currency hedging. There may be a greater difference between the past performance of the share class and the reference benchmark than for other share classes in the Fund.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, ICE BofA BB-B Developed Market High Yield Constrained Index (USD Hedged).
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is distributed.
- You may sell your investment on most working days.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.



Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 30 January 2025.
