# **Objectives and Investment Policy**

## Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of inflation linked bonds, while promoting environmental, social and governance (ESG) characteristics. The Fund aims to have a higher ESG score than its reference benchmark; calculated as a weighted average of the ESG scores of the issuers of the Fund's investments versus the weighted average of the ESG score of its reference benchmark.

The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at www.assetmanagement.hsbc.com/about-us/responsible-investing.

## **Investment Policy:**

The Fund will normally invest at least 70% of its assets in bonds, the value of which is linked to inflation.

The Fund invests in bonds issued by companies, governments or government related entities of developed markets and emerging markets. Up to 15% of the Fund's assets may be invested in emerging markets.

The Fund includes the identification and analysis of a company's ESG credentials as an integral part of the investment decision making process to help assess risks and potential returns. ESG credentials may include environmental and social factors, and corporate governance practices. Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on ESG credentials and excluded activities.

ESG credentials, excluded activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers. The Fund may invest in bonds denominated in developed market or emerging market currencies.

The Fund may invest up to 10% of its assets in Chinese onshore bonds through the China Interbank Bond Market (CIBM).

The Fund's primary currency exposure will be to US Dollars (USD). The Fund will normally hedge non-USD exposures into USD. At times, however, the Fund may have exposure up to 10% in non-USD currencies, including emerging market currencies. The Fund will not invest in securities issued by issuers with a credit rating below investment grade at the time of purchase, but may invest up to 10% in other funds, and may invest in bank deposits and money market instruments for treasury purposes.

## Why is this Fund in this specific category?

# Material risks not fully captured by the Risk and Reward Indicator:

- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Credit Řísk A bond or money market security could lose value if the issuer's financial health deteriorates.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may also use derivatives for hedging, efficient portfolio management purposes, cash flow management and tactical asset allocation. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency EUR and the base currency of the Fund USD.
- The reference benchmark, shown in the past performance section, does not take account of currency hedging. There may be a greater difference between the past performance of the share class and the reference benchmark than for other share classes in the Fund.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, ICE BofA Global Inflation-Linked Government Alternative Weighting Scheme Custom (USD hedged; net of transaction costs).
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- Any deviations with respect to the benchmark are monitored within a comprehensive risk framework, which includes monitoring at country level
- The deviation of the Fund's performance and underlying investments' weightings
  relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is distributed
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.



# Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.
