Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of US Dollar denominated high yield bonds, including non-investment grade rated bonds and other higher yielding securities.

Investment Policy:

In normal market conditions, the Fund will invest at least 90% of its assets in US dollar denominated non-investment grade rated and other high yield bonds and similar securities issued by companies that are based in or carry out the larger part of their business in developed markets, or securities issued by governments, government agencies or supranational bodies in any country including emerging markets. At least 70% of the Fund's assets will be invested in securities issued by companies that are based in the United States of America (USA), issuers guaranteed by the US government or US government agencies.

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for more details on excluded activities.

The Fund invests in bonds which are mostly denominated in US dollars (USD). At times the Fund may also invest in bonds denominated in other developed market currencies. Normally, investments in non-USD bonds will be limited to 10% of the Fund's assets and exposure to other developed market currencies will be hedged back into USD. The Fund may invest up to 10% in developed market currencies other than US dollars. The Fund may also invest up to 20% of its assets in bonds and similar securities issued in emerging markets.

The Fund may invest up to 15% of its assets in contingent convertible securities. However, this exposure is not expected to exceed 10%.

The Fund may invest in asset-backed securities (ABS) and mortgage-backed securities (MBS) through investment in other funds.

The Fund may invest up to 10% of its assets in other funds, including HSBC funds and may invest in bank deposits and money market instruments for treasury purposes.

The Fund may invest up to 10% of its assets in securities issued by or guaranteed by any single government issuer with a credit rating below investment grade. The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings. The Fund may also invest in derivatives. The Fund may use them for hedging, cashflow management and investment purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, ICE BofA US High Yield Constrained (net of transaction costs).
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance relative to the benchmark is also monitored, but not constrained, to a defined range.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

Why is this Fund in this specific category?

This Fund is classified in category 4 because its price or simulated data has shown medium fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively
 impact the performance of callable debt securities (securities whose issuers have the
 right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.

- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Credit Řisk A bond or money market security could lose value if the issuer's financial health deteriorates.

- Operational Risk Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.



HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 06 May 2025.
