Objectives and Investment Policy

Investment Objective:

The Fund aims to provide capital growth and income by investing in a portfolio of bonds and other similar securities for a limited term.

Investment Policy:

The Fund is intended to be in operation until 31 December 2022 (the "Term Date"). On the Term Date, the Fund will be liquidated and shares of the Fund will be compulsorily redeemed at the prevailing valuation per share.

The Term Date may be deferred for up to 3 months if the Board of Directors believes it is in the best interest of shareholders.

The Fund will seek to invest in bonds with a final maturity date close to the Term Date, aiming to hold them to maturity whilst actively monitoring and maintaining the portfolio.

As the term date approaches, the Fund's assets will increasingly comprise of cash and money market instruments.

The Fund will mainly invest in investment grade bonds and noninvestment grade bonds issued by governments, government-related entities, supranational entities and companies based in both developed markets and emerging markets. The Fund will use derivatives to swap its fixed coupon income (received from ownership of fixed rate securities) into a floating rate.

Risk and Reward Profile

Why is this Fund in this specific category?

This Fund is classified in category 4 because its price or simulated data has shown medium fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively impact the performance of callable debt securities (securities whose issuers have the right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.

The Fund may invest up to 10% of its assets in other funds, including HSBC funds.

The Fund will normally hedge non-US dollar exposures into US dollars (USD). At times, however, the Fund may have exposure to non-USD currencies, including emerging market currencies. Normally the Fund's exposure to non-USD currencies will be limited to 10% of its assets. The Fund may also invest in derivatives. The Fund may use them for hedging, cashflow management and investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, ICE LIBOR USD 3 Month.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may be appropriate for investors who plan to invest over a short term.
- Credit Risk A bond or money market security could lose value if the issuer's financial health deteriorates.
- Default Risk The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- Derivatives Risk Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.

- Operational Risk Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.

Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between subfunds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other subfund.
