Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of United States of America (US) shares. **Investment Policy:**

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size that are based in or carry out the larger part of their business as activities in, the US.

Companies considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset


Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on excluded activities.

The Fund's investment process identifies and invests in companies according to their economic scale, measured by their contribution to Gross National Product. This is also referred to as Value Added - the difference between a company's outputs and inputs.

The Fund may invest up to 10% in Real Estate Investment Trusts (shares in property companies).

The Fund may also invest up to 10% of its assets in other funds, including HSBC funds, and may invest in bank deposits and money market instruments for treasury purposes.


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.
