Investment objective

The Fund aims to provide long term capital growth and income by investing in a portfolio of global bonds, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of SFDR.

Investment strategy

The Fund is actively managed and is not constrained by a benchmark. The Fund employs a Total Return strategy which has a flexible allocation across the global bond universe and currency markets, over an investment cycle, to achieve risk-adjusted returns above those of the investment universe. The Fund will primarily invest in investment grade bonds and non-investment grade bonds issued by governments, government-related entities, supranational entities and companies that are based in in developed or emerging markets. The Fund includes the identification and analysis of an issuer's environmental and social factors and corporate governance practices as an integral part of the investment decision making process. The Fund may invest up to 10% in onshore Chinese bonds, up to 10% in non-investment grade securities; up to 30% in assetbacked securities and mortgage-backed securities; up to 10% in other funds. The Fund's primary currency exposure is to USD. See the Prospectus for a full description of the investment objectives and derivative usage.

🖄 Main risks




