Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a diversified portfolio of non-investment grade and unrated bonds and other similar securities issued by governments, government-related entities, supranational entities, and companies, while promoting environmental, social and governance (ESG) characteristics.

The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at www.assetmanagement.hsbc.com/about-us/responsible-investing. Investment Policy:

In normal market conditions, the Fund will invest at least 80% of its assets in noninvestment grade and other higher yielding securities (including unrated bonds) issued by issuers with consideration of their meeting certain ESG score and lower carbon intensity criteria (ESG and Lower Carbon Criteria).

ESG and Lower Carbon criteria, together with fundamental qualitative issuer analysis, are used to determine the Fund's investible universe; including issuers following good ESG practices and sustainable bonds. Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies and the Paris Aligned Benchmark exclusions which may change from time to time. Please refer to the Prospectus for more details on ESG and Lower Carbon criteria, and excluded activities.

ESG and Lower Carbon criteria, excluded activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers.

The Fund invests mostly in bonds denominated in or hedged into US dollars and may have exposure of up to 20% to non-USD currencies.

The Fund may invest up to 10% of its assets in securities issued by any single government issuer with a non-investment grade rating, up to 10% in convertible bonds and up to 10% in asset backed securities (ABS).

The Fund may invest up to 15% of its assets in contingent convertible securities. However, this is not expected to exceed 10%.

The Fund may invest up to 10% in Chinese onshore bonds through the China Interbank Bond Market (CIBM), up to 10% in other funds; and may also invest in bank deposits and money market instrument for treasury purposes.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may invest in derivatives and use them for purposes of managing interest and credit risks and currency positioning. Derivatives will not be used extensively for investment purposes. Derivatives may be embedded in other instruments used by the Fund

- ٠ The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency EUR and the base currency of the Fund USD.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, ICE BofA BB-B Developed Market High Yield Constrained Index (USD Hedged).
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance relative to the benchmark is also monitored, but not constrained, to a defined range.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 3 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.

Why is this Fund in this specific category?

This Fund is classified in category 4 because its price or simulated data has shown medium fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively impact the performance of callable debt securities (securities whose issuers have the right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.

- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations. Credit Risk A bond or money market security could lose value if the issuer's
- financial health deteriorates.
- Default Risk The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- Derivatives Risk Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- Exchange Rate Risk Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.

- Investment Leverage Risk Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- Liquidity Risk Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- Operational Risk Operational risks may subject the Fund to errors affecting ٠ transactions, valuation, accounting, and financial reporting, among other things.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.



Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 30 April 2025.
