Objectives and Investment Policy

Investment Objective:

The Fund aims to make a positive environmental, social and governance (ESG) impact, by investing in bonds and other similar securities issued by companies that contribute to United Nations Sustainable Development Goals (Contributing Companies and SDGs), while also aiming to provide long term capital growth and income. The Fund promotes ESG Characteristics within the meaning of Article 9 of SFDR. Investment Policy:

In normal market conditions, the Fund invests at least 90% of its assets in investment grade and non-investment grade bonds and unrated bonds and other similar securities issued by Contributing Companies, that are based in emerging markets. The Fund's investments will be primarily denominated in US Dollar.

The SDGs that the Contributing Companies contribute to include: Climate Action, Affordable and Clean Energy, Clean Water and Sanitation, Good Health and Well Being and Reduced Inequalities.

The Fund will also invest in ESG labelled bonds that are aligned with the International Capital Market Association (ICMA) principles, which will not necessarily be issued by Contributing Companies. The Fund's ESG impact is analysed as the fundamental consideration when determining the investment universe. The Fund's investment principles together with ESG impact analysis and fundamental qualitative company/ issuer analysis are used to determine the Fund's investments, that include: continuous engagement with Contributing Companies/Issuers regarding their ESG credentials and their ESG credentials at various stages of their ESG transition; companies/issuers following good ESG practices (for example, resulting in low and/or decreasing carbon intensity); and labelled securities aligned with ICMA Principles.

Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies and the Paris Aligned Benchmark exclusions. Please refer to the Prospectus for more detail on ESG impact analysis and excluded activities.

Labelled securities, excluded activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers.


The Fund may invest up to 15% of its assets in contingent convertible securities. The Fund may invest up to 10% of its assets in onshore Chinese bonds, up to 10% in convertible bonds, up to 10% in other funds (which will qualify under Article 9 of SFDR) and may invest in bank deposits and money market instruments for treasury purposes. The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings. The Fund may also invest in derivatives and use them for hedging, cash flow management and efficient portfolio management purposes. Derivatives may also be

Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively
 impact the performance of callable debt securities (securities whose issuers have the
 right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.



Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between sub-funds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other sub-fund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 30 April 2025.
