Objectives and Investment Policy

Investment Objective:

The Fund aims to make a positive environmental, social and governance (ESG) impact, by investing in bonds and other similar securities issued by companies that contribute to United Nations Sustainable Development Goals (Contributing Companies and SDGs), while also aiming to provide long term capital growth and income. The Fund promotes ESG Characteristics within the meaning of Article 9 of SFDR. In normal market conditions, the Fund invests at least 90% of its assets in investment grade and non-investment grade bonds and unrated bonds and other similar securities issued by Contributing Companies, that are based in emerging markets. The Fund's investments will be primarily denominated in US Dollar.

The SDGs that the Contributing Companies contribute to include: Climate Action, Affordable and Clean Energy, Clean Water and Sanitation, Good Health and Well Being and Reduced Inequalities.

The Fund will also invest in ESG labelled bonds that are aligned with the International Capital Market Association (ICMA) principles, which will not necessarily be issued by Contributing Companies. The Fund's ESG impact is analysed as the fundamental consideration when determining the investment universe. The Fund's investment principles together with ESG impact analysis and fundamental qualitative company/ issuer analysis are used to determine the Fund's investments, that include: continuous engagement with Contributing Companies/Issuers regarding their ESG credentials and their ESG credentials at various stages of their ESG transition; companies/issuers following good ESG practices (for example, resulting in low and/or decreasing carbon intensity); and labelled securities aligned with ICMA Principles.

Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies and the Paris Aligned Benchmark exclusions. Please refer to the Prospectus for more detail on ESG impact analysis and excluded activities.

Labelled securities, excluded activities and the need for enhanced due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework as well as research & information provided by financial and non-financial data providers.

Why is this Fund in this specific category?

This Fund is classified in category 5 because its price or simulated data has shown medium to high fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively
 impact the performance of callable debt securities (securities whose issuers have the
 right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.

The Fund may invest up to 15% of its assets in contingent convertible securities. The Fund may invest up to 10% of its assets in onshore Chinese bonds, up to 10% in convertible bonds, up to 10% in other funds (which will qualify under Article 9 of SFDR) and may invest in bank deposits and money market instruments for treasury purposes. The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings. The Fund may also invest in derivatives and use them for hedging, cash flow

management and efficient portfolio management purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency GBP and the base currency of the Fund USD.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is JP Morgan ESG Corporate EMBI Broad Diversified.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a material percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.
- This product is based overseas and is not subject to UK sustainable investment labelling and disclosure requirements.
- Credit Risk A bond or money market security could lose value if the issuer's financial health deteriorates.

The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.


