Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of bonds and shares. The Fund seeks to apply a medium to high risk investment strategy.

Investment Policy:

In normal market conditions, at least 90% of the Fund's exposure is to bonds, shares and alternative investment strategies (which includes real estate, private equity, hedge fund strategies and commodities). The Fund gains exposure to bonds (or other similar securities) that are investment grade, non-investment grade and unrated issued by the government, government-related entities, supranational entities and companies based in developed markets and emerging markets. The bonds can be denominated either in US dollars (USD) or developed markets currencies hedged into USD. The Fund gains exposure to shares (or securities similar to shares) issued by companies of any size. Exposures are achieved by the Fund through investing directly into markets or by investing in other funds.

The Fund may invest up to 100% of its assets in other eligible funds although this investment will normally be between 50% and 100%; can have exposures to bonds (or other similar securities) of up to 50% of its assets, and shares (or securities similar to shares) up to 100% of its assets.

Risk and Reward Profile

Why is this Fund in this specific category?

This Fund is classified in category 4 because its price or simulated data has shown medium fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Credit Risk A bond or money market security could lose value if the issuer's financial health deteriorates.
- Default Risk The issuers of certain bonds could become unwilling or unable to make payments on their bonds.

The Fund may invest up to 20% of its assets in non-investment grade and unrated bonds.

The Fund may invest, in aggregate, up to 35% of its assets in alternative investment strategies. Individually, the Fund's exposure to these strategies shall not exceed 15% to real estate (indirectly), 20% to hedge funds and 10% each to private equity, commodities and absolute return funds.

The Fund's primary currency exposure is to USD.

The Fund may also invest in derivatives. The Fund may use them for hedging, cashflow management and investment purposes.

- The reference currency of the Fund is USD. The reference currency of this share class is GBP.
- The Fund is actively managed and is not constrained by a benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Charges


The charges you pay are used to pay the running costs of the Fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.
